1. GVTC Update- Robert Keown and Pam Warren

Continue to work with Adult Ed. and Economic Development.
Reminded folks to complete Banner coding survey.

2. E-Campus – Steven Ferguson

Governor's press release. TCSG will receive money through GEERS for \$10.4 million to build out the program. Groups will be pulled into the discussion and implementation process.

3. Best Practice Sessions- Sandra King

Curriculum specialists will be holding best practice sharing sessions with curriculum groups who requested discussions. Sandra will send the spread sheet out to the list service later today.

4. Limited Labs- Cosmetology- Kathryn Hornsby

- Referenced Josh McKoon's email. If you want to have live work for cosmetology, you can do so. You can also still use mannequins. It's a college choice. You do not need to submit a limited lab request.
- Per Anthony - I was able to get clarification from Josh McKoon, legal counsel. Permission is not needed for students to work on each other. Live work is now available for the general public and students alike as long as CDC and State Board of Cosmetology and Barbers recommendations are followed.

5. TSCG Code of Conduct Update (with regard to the mask requirement)- Joe Dan Banker

Reviewed the document, Interim Addendum Code of Conduct. Address as you would any other code of conduct concern. Josh McKoon addressed accommodations for students who do not want to wear a mask or shield.

6. SB359 – Does this replace the need for limited lab student waiver requirement?- Joe Dan Banker

- Yes, if you are in compliance with the bill regarding signage, it is not necessary to have students sign waivers. You may do so however, if you wish.
- Dual Enrollment students (underage, high school), do require a waiver signed by parent or guardian.

7. KMS Pre-Enrollment Report Update- Kathryn Hornsby

- Fall enrollment is improving, but is still down 11% statewide. 4 colleges do have increased enrollment.
- Increased online enrollment.
- New student numbers have decreased.
- Dual Enrollment numbers have decreased. Per Dianne, some schools/districts are allowing students to take either virtual or in person classes. However, for students who choose

virtual learning, those students are not being allowed to enroll in dual enrollment. In addition, some high schools will not be starting until after Labor Day.

8. Discussion- Disinfecting guidelines faculty/students are using for classrooms and labs for those colleges that have already started fall semester.
