DISCUSSION	<p>TCSG Name Change Changing the name of the state agency from the Technical College System of Georgia to Georgia Career College System is being considered.</p> <p>New TCSG Commissioner In January, Gretchen Corbin, was installed as the new Commissioner.</p> <p>State Stats for BAFN Program Enrollment and graduation statistics for the BAFN program were reviewed. Collectively the programs at Central Georgia, Georgia Piedmont, and Wiregrass Georgia increased the number of awards to 62 in AY2014 from 35 awards in AY 2013. Total enrollment in 2014 was 131 students.</p>

The intent of the event was to gain more exposure for the program on campus and within the community. Approximately 100 people attended the event. - The BAFN advisory committee was combined with the ACCT advisory committee, which has a combined membership of 15. - In March, Ms. Pollard will join with Wells Fargo for a community event. <p>GPTC is investigating ACBSP accreditation.</p> <p>Wiregrass Georgia:</p> <ul style="list-style-type: none"> - Mr. Moore is interested in adding curriculum for electronic services to his program. - He is investigating websites and software programs that provide students an opportunity to "practice" entering transactions. <p>Interns have been successful in achieving over 90% placement with the firms that sponsored their internships.</p> <ul style="list-style-type: none"> - He wants to review the FA11 TCC to determine if it would be an appropriate TCC to embedded in their BAFN degree.
