TICKET INFORMATION:

The Web Design and Development IFCC met in April 2022 to review, discuss, and vote on proposed curriculum revisions by the Chair and Vice-Chair. The IFCC Chair and Vice-Chair proposed the following updates to the Web Design and Development programs:

- Increase the credit and contact hours for the required courses: CIST 1510, CIST 1520, and CIST 2550. The IFCC Chair and Vice-Chair cited that the additional contact time will allot sufficient time for faculty to address the increases in complexity and capabilities of the current industry standards.
- Replace the requirement of option cluster (CIST 2531 Web Graphics II or CIST 2541 Web Animation II) with
 a general elective in the state standard and institutionally developed Web Design and Development TCC,
 diploma and degree programs. The reason cited for this change was these courses duplicate much of the
 knowledge gained from the initial course and provide little benefit to the students.
- Remove the requirement of CIST 2921 IT Analysis, Design, and Project Management from state standard. and institutionally developed Web Design and Development TCC, diploma and associate degree programs.
- The full IFCC voted in agreement with the proposal, which will result in an increase of three (3) credit hours from each program listed above and will also impact other programs within the Cyber and related, Marketing Management, and Business and Office Technology PAS Groups.

The table below displays the impact of the proposed changes to CIST 1510, CIST 1520, and CIST 2550 on the Web Design and Development programs as well as other programs in the Cyber and related and other PAS groups. Colleges offering the programs listed above have three weeks to vote on this probe. Presidents can then review the results during their next scheduled meeting.
