TICKET INFORMATION:

The NLB3: Nursing LPN Bridge Option program is an institutional developed program belonging to Columbus Technical College. In 2014, the college revised its RNSG courses & curriculum. They obtained approval from the GA Board of Nursing (GBON) & the Accreditation Commission for Education in Nursing (ACEN) of the course/curriculum revisions, resulting in creating the 2014 version of the NU23 program.

However, a 2014 version of the NLB3 program should have been created to reflect those approved revisions but was not. The current 2010 version of the NLB3 program remained within the curriculum database at a total of 71 credit hours. The college is requesting that the NLB3 program be updated to reflect the revisions made within 2014.

In an effort to reflect those revisions, a 2021 version of the NLB3 program has been created. The credit hours have been reduced from 71hrs to 70hrs. However, this reduction will not impact the program's daily operations; since the college requires a 3-hr seminar course for all students. Overall the revisions are listed below, and State Board will review the program in August.

- Removal of the following courses,
 - RNSG 1130: Foundations for Bridge to Professional Nursing
 - RNSG 1130: Health Assessment throughout the Life Span
 - RNSG 1140: Pharmacology and Dosage Calculations

 - RNSG 2100: Professional Practice III: Health Promotion for Women's Health and the Child Bearing Family
 - RNSG 2120: Professional Practice IV: Health Promotion and Restoration for Mental Health
 - RNSG 2140: Professional Practice V: Health Restoration Adult & Child
 - RNSG 2150: Professional Practice VI: Complex Care for Adult and Child
 - RNSG 2160: Professional Practice VII: Role Transition for Professional Nursing
- Replace the removed courses with the following courses,
 - RNSG 1111: Medical- Surgical I-Foundations of Health Promotion, Maintenance, and Restoration Across the Lifespan
 - RNSG 1125: Psychiatric NSG: Mental Health Promotion Maintenance and Restoration Across the Lifespan
 - RNSG 2121: Medical-Surgical II Health Promotion, Maintenance, and Restoration Across the Lifespan
 - RNSG 2205: Maternal Nursing Health Promotion, Maintenance, and Restoration

- RNSG 2131: Medical-Surgical III: Complex Care, Health Promotion, Maintenance, & Restoration Across the Lifespan
