The learning outcome removed from OCTA 3210 and OCTA 3320 is better aligned within the OCTA 1020 course since the ACOTE standard B.4.21: Teaching-Learning Process and Health Literacy is addressed within the OCTA 1020 course. Furthermore, the IFCC agrees that the learning outcome is better suited within the same course that provides instruction and assessment. Overall the modifications to these courses did not impact the credit or contact hours. The OTA3 program remained at 73 credit hours.
